**\$19,000 in Drugs Seized by County Narcotics Task Force**

**TRENTON** – The Mercer County Prosecutor's Office announced that a two-month investigation led by his Special Investigations Unit (SIU), under the command of Lt. Mike Novembre, concluded last week with three arrests, and the seizure of cocaine, ecstasy and marijuana.

On May 10, at approximately 3:15 p.m., members of the Mercer County Narcotics Task Force executed search warrants at two locations in Trenton. When SIU officers, the New Jersey State Police, the Mercer County Sheriff's Office and the Ewing, Hamilton and Lawrence police departments executed search warrants at 433 Euclid Avenue, **MARK WISE**, **ROGER DAWKINS** and **LEAH GREIF** were located inside and detained. During a search of the residence, a plastic bag containing approximately 60 grams of crack cocaine was found underneath a mattress and a plastic bag containing approximately 113 grams of powder cocaine was found in a jacket pocket. Smaller amounts of crack cocaine were found in other locations throughout the residence, and three sifters, latex gloves and additional drug paraphernalia were found in the kitchen. A search of Greif's pocketbook revealed approximately five grams of ecstasy.

Officers also searched a second-floor apartment at 210 South Clinton Avenue, where Wise and Greif reside. Approximately 10 grams of marijuana were found, along with a digital scale and numerous plastic baggies.

Crack cocaine was located in Dawkins' sock and Wise had \$2,214 on him at the time of his arrest. A 2008 BMW and a 2007 Infiniti were seized as drug proceeds.

Novembre stated that the approximate street value of the crack cocaine is \$7,400; the approximate street value of the powder cocaine is \$11,300; the approximate street value of the ecstasy is \$400; and the approximate street value of the marijuana is \$100.

**WISE**, age 42, of South Clinton Avenue, is charged with possession of a controlled dangerous substance, possession with the intent to distribute, possession with the intent to distribute within 1,000 feet of a school, possession of marijuana and possession of drug paraphernalia. He is being held at the Mercer County Correction Center in lieu of \$200,000 bail.

**DAWKINS**, age 51, of Euclid Avenue, is charged with possession of a controlled dangerous substance, possession with the intent to distribute, possession with the intent to distribute within 1,000 feet of a school and possession of drug paraphernalia. He is being held at the Mercer County Correction Center in lieu of \$150,000 bail.

**GREIF**, age 25, of South Clinton Avenue, is charged with two counts of possession of a controlled dangerous substance, two counts of possession with the intent to distribute, two counts of possession with the intent to distribute within 1,000 feet of a school, possession of marijuana and possession of drug paraphernalia. She was released on \$150,000 bail.

Despite having been charged, every defendant is presumed innocent until found guilty beyond a reasonable doubt in a court of law.
